False Claims Act	<p>Ass't. Attorney General Joshua Jackson presented on the particulars of the False Claims Act</p> <p>A Violation of the False Claims Act may result in a civil penalty. Examples of filings under the False Claims Act:</p> <ul style="list-style-type: none"> ▪ Billing for services not provided ▪ Double billing-billing twice for same service but absent patient ▪ Filing False information or making false statements-one should provide all information pertaining to services ▪ Upcoding-overstating service provided ▪ Unbundling-billing separate services ▪ Billing for excessive services <p>False Claim Act is attached to this document</p>

Site Visits	<p>Judi Jordan provided an update on site visits</p> <ul style="list-style-type: none"> ▪ DCF is currently improving the site visit system ▪ DCF responsibility to ensure that everything is accordingly to the credentialing policy ▪ Maintaining accurate track record keeping ▪ Developing an improved and streamlined review form and check list ▪ Tiered system was implemented for contracted-providers and involved provider input to improve system. May ask for provider input in this system as well. ▪ Maintaining updates on ABH-DCF Credentialing website ▪ Notification of site visits via letter to the provider. Site visit information is included in the provider Agreement (Monitoring and Review)
Transportation	<p>Ann Adams provided an update on transportation</p> <ul style="list-style-type: none"> ▪ Any one providing transportation as a service that is not credentialed will not be paid for their services. Fiscal services is reviewing all invoices and contacting those providers that have not initiated credentialing arrangements with ABH.
Supervised Visitation	<p>Ann Adams provided an update on Supervised Visitation</p> <ul style="list-style-type: none"> ▪ As slots for RTFT have become filled it has become apparent that openings are needed for the credentialed Supervised Providers. Be aware that not all regions are accepting credentialed Supervised visitation Services at this time. As the Provider Agreement states, there is no guarantee of utilization of services. All credentialing information can be found on ABH's website.
